Notice of Settlement Approval and Claims Procedure

THIS NOTICE MAY AFFECT YOUR RIGHTS, PLEASE READ CAREFULLY

WHO SHOULD READ THIS NOTICE

You should read this notice if you had sperm samples stored with the UBC Andrology Lab as of May 2002. You may be a class member and will be bound by the terms of the Settlement Agreement, set out below, unless you are not a member of the class.

SETTLEMENT

The British Columbia Supreme Court approved the Settlement Agreement on June 23, 2015. The settlement allows class members to apply for compensation for certain losses relating to a power interruption to a freezer at the Andrology Lab in which their sperm samples were stored in May 2002. Availability of compensation depends on a number of variables which are set out in the Settlement Agreement. Court approval is not a finding of liability and UBC has denied and continues to deny the allegations against it.

WHO IS INCLUDED IN THE SETTLEMENT

Class Members are all persons whose sperm was stored in the University of British Columbia's Forma Scientific Inc. freezer model 8382 in May 2002 but not including persons who had anonymously donated their sperm.
